CENTRAL COMMITTEE MEETING HELD AT HYDERABAD

The 15th Central Committee meeting of SBPRA was held on 25.8.2019 at Hotel NKM Grand, Somajiguda Hyderabad. Com. Dinkar S Punja, Chairman, SBPRA chaired the meeting. Com R K Sharma, President was also present. SBOA was represented by Com. Sanjay Manjrekar, General Secretary. The proceedings commenced with observance of two minutes silence to pay homage to the notable personalities and members who passed away during the intervening period. Com Dinkar Punja congratulated the President, the General Secretary and the entire CC team for various achievements such as holding structured meetings; increase in bank reimbursement of insurance premium, parity of VRS retirees with that of superannuation retirees; entry in customers' service committees at all levels from branch to corporate office of the bank, growth of membership. Com R K Sharma President touched upon the proceedings of AIBPARC GC meeting held in New Delhi recently. Com S A Manjrekar, GS, SBOA explained in detail wage revision talks in his knowledge as a member of AIBOC Negotiating Team; internal discussions/ pressures among UFBU constituents; Boycott of talks by AIBOC; Decision to go for independent actuarial calculation of pension Updation cost; the IBA Insurance Policy Premium and Brokerage. Then the General Secretary Com Gangadhar Yadav dealt with the agenda, appraised the house on organisational matters and of office bearers meeting executives at corporate office of the Bank for follow up on pending issues. Thereafter the agenda of next Central Conference i.e. General Body meeting date, venue, cut off date and Zonal Meetings (Zonal Conferences) dates and venue was taken up. After a thorough consideration of the matter the following time table was finalised.

- 1. Triennial General Body Meeting (Central Conference) to be held on Sunday the 17th November 2019 at Hyderabad, Inaugural Session to commence @10.00 am and Delegate Session to follow.
- 2. Triennial Zonal Meetings (Zonal Conferences) to be held on 15.9.2019, 21.9.2019, 22.9.2019, 28.9.2019 and 29.9.2019. Notice with detailed schedule venue, date and time will be issued by the General Secretary separately.
- 3. The number of office-bearers i.e. Zonal Secretary, Regional Secretaries and Zonal Committee Members and Delegates of each zone eligible as per Bye Law clause 11(a) of the Association were worked out based on the membership on the rolls of the Association as on 30th June 2019 as per clause 4 (d) of Association. The details to be communicated in the notice to be issued by the General Secretary separately.

Thereafter the issue of support to be extended in the court case in the matter of reckoning Spl allowance for terminal benefits filed by general members at Lucknow came up for discussion. After discussing options it was decided that SBPRA shall file a WP in this matter in Lucknow Bench of Allahabad High Court. It was also decided to entrust the work of engaging a lawyer/s, preparing the papers and filing the case to Com. Rakesh Dua, the Central Committee Member.

Then the matter of WP to be filed in the matter of retirees who served as Temporary Attenders was taken up. Developments in the matter were appraised to the house. As the matter had already progressed the discussions with the lawyers were already over the authorisation i.e. Vakalatnama

on behalf of SBPRA was signed by the General Secretary and it was handed over during the meeting to Com A Venkatesan, Vice President who was entrusted with work pertaining the WP.

Thereafter a detailed presentation of zonal activities by the members was made. Among the issues deliberated were the need to implement the bye law clause to constitute District Secretaries; introduction of Death Relief scheme however small the amount may be; creation of a post of Dy Zonal Secretary at the rate of one for each zone; Flood Relief loan to affected comrades; denial of addl stagnation increments to post-2012 retirees; need to create help desk at ROs for IBA health insurance; need to hold monthly meetings at all major centers; monthly subscription rejection lists for follow up; commutation arrears on DA merger anomaly in respect of difference in CPI 1616 - 1684; CRS retirees leave encashment etc. The General Secretary assured to take steps/ follow up appropriately. Thereafter accounts for the period under review were placed on record and the same were approved.
