## EX-GRATIA FOR PRE-1986 RETIREES IMPROVED

We are happy to inform that ex-gratia amount paid to pre-1986 retirees has since been improved. A communication has been issued by IBA vide Ref. HR&IR/MBR/743/2022--23/11722 dated 7th February, 2023 to all the PSBs advising to consider payment of additional ex-gratia over and above the amount that is being paid as per DFS guidelines so as to ensure that the surviving Pre-86 Retirees/surviving spouses get a minimum amount of Rs 10,000/-- per month as ex-gratia. This was one of the issues taken up by AIBPARC with the Hon'ble Union Finance Minister, Officials of Ministry and IBA and ultimately clinched the same. A circular issued by AIBPARC in this regard with full details is attached herewith for information of all.

**Sub: Improvement of ex-gratia paid to Pre-- 1986 Retirees.**

We have much pleasure to convey that IBA by its communication: HR&IR/MBR/743/2022--23/11722 dated 7th February, 2023 to The Chairman, SBI and MD&CEOs of PSBs has advised to consider payment of additional ex-gratia over and above the amount that is being paid as per DFS guidelines so as to ensure that the surviving Pre--86 Retirees/surviving spouses get a minimum amount of Rs 10,000/-- per month as ex-gratia.

We shall write to IBA soon regarding sending of the same kind of Advisory to all Member Banks otherwise another discrimination will crop up which can be easily avoided.

Members are well aware of the fact that this has been one of the core issues for which AIBPARC has been escalating and agitating for a considerable period of time. We have talked with the Hon'ble Union Finance Minister, Officials of Ministry and IBA to get the issue resolved. We are happy about it and we convey our sincerest thanks and gratitude to all concerned.
