**Sub: Programmes of phase-wise agitation declared by the organisation
vide circular 25-23 dated April, 24, 2023.**

The relevant extract of the circular is quoted hereunder :

“On any day between 1st May, 23 to 15th June, 23 each state unit will organise protest rally/Dharna/Demonstration at State capitals. An unusually long period of 45 days has been allowed because of the extremely uncomfortable climatic condition. Depending on the weather situation, the state committees are to implement the programme. On the date of holding the programme, the state Secretary/President will send a letter to Union FM by mail requesting early resolution of demands. Format will be supplied by the central office.”

In view of the above, we request all the state committees to finalise the date of the programme at an early date and keep us posted about it. On conclusion of the programme, a brief report is also to be sent to us. As regards the format of the letter, it will be made available by circular as early as possible.
