Meeting of CBPRO and AIBRF at Delhi on 24th October 2018

As already informed to you, a meeting OF CBPRO & AIBRF leadership took place on 24th October 2018 at Delhi.

It was decided that the Coordination should aggressively chalk out programmes to realise the core issues of Bank Retirees - 1. Family Pension 2. Pension Updation. 3. 100%DA Neutralization. 4. Full Reimbursement of Medical Insurance Premium to Retirees. 5. Reckoning of Special Allowance for Superannuation Benefits retrospectively from 10th Bipartite Settlement. 6. IBA should hold talks with the Coordination Body of Bank Retirees.
