You are all aware that we have implemented various action programs launched by AIBPARC earlier, except the Dharna program at Delhi which was cancelled at the last moment due to withdrawal of police permission due to the then ongoing farmers' agitation in NCR Area. Now AIBPARC/CBPRO have decided to re-launch the program of staging a Centralized Dharna at Jantar Mantar, Delhi on 23rd October, 2024 to demand immediate resolution of the long pending issues of Pension Updation; Computation of Special Allowance in the calculation of pension and gratuity; health insurance at affordable cost; restoration of the commuted value of pension after 10 years; immediate payment of ex-gratia in Private Sector Banks; consultative status for apex level Retiree organizations to sort out all issues of Bank Pensioners and Retirees etc. We shall issue further guidelines to all our members/retirees in NCR for participation in the Dharna. Let us participate in the program in large numbers and make the same a thumping success.
