### AMENDMENTS TO BYELAW - PROPOSED

We furnish here below the amendments to the byelaw of the Association proposed by the Central Committee to be placed before the General Body Meeting of the Association to be held online on Sunday the 6<sup>th</sup> of Feb 2022 in terms of Notice circulated vide our Cir no. 2/2022 dt 16.1.2022.

Clause No.	Amendment/Changes proposed	The clause after amendment reads as:
GENERAL BODY 7. A) b) 3.	Add: once in 3 years.	To elect Central Committee (Governing Body) in terms of Clause 14. h (i.e., once in 3 years).
7. B) b.	Replace 10 Vice Presidents with 11 Vice Presidents	The Central Committee (Governing Body) shall comprise the following office-bearers: President, Working President, Eleven Vice Presidents, General Secretary, Secretary, Treasurer, Joint Treasurer, Ten Joint Secretaries, Ten Zonal Secretaries and The Nominated members
7. D) a. 6.	Replace “permanent invitees” with “ex-officio members of the Zonal Committees”	The central office bearers i.e., members of Central Committee (Governing Body) of the Association stationed in the Zone shall be ex-officio members of the Zonal committee (Area Committees)
8. D) 2 <sup>nd</sup> Para	Number of delegates eligibility of Zone is clarified	To elect office-bearers of the Zone (Area) i.e. Zonal Secretary, Deputy Zonal Secretary, Regional Secretaries (as many as bank’s Regional Offices) and Zonal Committee Members in the ration of 50:1 of the membership in the Zone (maximum 30). All the office bearers will be delegates to the Triennial Central Conference. Additional number of delegates will be elected to Triennial Central Conference in such a way that total number of delegates including office bearers does not exceed the ratio of 30:1 of the membership in the zone.

8. E	Delete repetition "in the respective zones in the ratio of 30:1" and add: all the Central Committee (Governing Body)	Once in 3 (Three) years a Triennial Central Conference shall be convened to review the activities of the Association. All the Central Committee (Governing Body) Members and all Zonal office bearers and delegates elected at the Triennial Zonal Conferences shall constitute the Triennial Conference. Triennial Central Conference shall be the Advisory Body of the Association

11. A)	Replace: Syndicate Bank with "Canara Bank"	The financial year shall be from April to March. The Association shall make due provision for the annual audit of the Accounts of the Association by competent auditors, satisfying the conditions laid down under Society Act. The general funds of the Association shall vest in the Central Committee (Governing Body) who shall open an account with Canara Bank, to be operated by the Treasurer jointly with the President or General Secretary. The Central Committee (Governing Body) may entrust operation of Bank accounts if need be by any two members of the Central Committee. On no account monies received shall be utilized directly for meeting payments but all expenditure shall be met by withdrawing funds from the Bank.
13. a	Replace: 'delegates' with 'members'	The Byelaws of the Association may be amended, altered, rescinded or added to at any time by a two-third number of the members present and voting at the General Body Meeting
13. b	Replace:" purpose' with "aims and objectives"	No amendment or alteration shall be made to the "aims and objectives" of the Association unless they are voted by 2/3 <sup>rd</sup> of members at a General Body Meeting convened for the purpose and confirmed by 2/3 <sup>rd</sup> of the members present at second special Meeting.

2. Any other amendments proposed by the members may be sent to the General Secretary at least three days before the commencement of the General Body Meeting, so that the same can be placed before the Central Committee and General Body Meeting.
