Dear Comrade,

Sub: Meeting of CBPRO at New Delhi.

We have pleasure to convey to all concerned that the constituents of CBPRO had a very purposeful meeting on 21st February, 2024 at New Delhi. The 3-hour long meeting took stock of the situation prevailing in the Banking Industry in an atmosphere of mutual understanding and adopted the following decisions:

- 1. The meeting of CBPRO will take place at least twice a year.
- 2 CBPRO--Specific Communications and Circulars on common issues concerning SBI and other Banks will be issued jointly by Com. Dipak Kumar Basu, the General Secretary of the Federation of SBIPAs and Com. K V Acharya, President, AIBPARC as Joint Convenors of CBPRO.
- 3. The communications of CBPRO will generally be on such issues as are applicable to all the constituents of CBPRO. It will be principally covering issues like Pension updation, special allowance not being computed for the purpose of calculation of pension and gratuity, consultative status of apex level Retiree organisations in the matters related to the

interest of Retirees. The letters will generally be addressed to Finance Minister, Secretary Finance/ DFS, MOF, GOI, the Chairman, IBA and the Grievance redressal department of Pensioners, GOI etc.

- 5.
