As per latest information the salary of staff and pension of ex-staff of both the banks for the month of April 2020 will be disbursed from a single point through HRMS of Canara Bank. So, it is now time for us to come to grips with present reality and engage in a dialogue with the management of Canara Bank as a part of our duty to get redressal of grievances of our members/ retirees.
