To All the Constituents of CBPRO:

Dear Comrades,

Sub: Hunger Strikes coinciding with Demonstrations/ General Meetings at all State Capitals or any other important centre of the state throughout the Country on 31<sup>st</sup> July 2025 (or any convenient date decided at state level) to highlight the long pending and unresolved issues of the Pensioners and the Retirees with the aim of early resolution – proposed centralized Hunger Strike at Delhi in August/September 2025.

The Constituents of CBPRO and several lakhs of Pensioners and Retirees who are the members of organizations are well aware of the following facts:

- 1. CBPRO has been consistently fighting for achieving several long pending demands. Several lakhs of emails have been sent by the Pensioners and the Retirees to the Hon'ble PM, HM and FM on all the pending issues and the legitimate demands of the senior and the super senior citizens of the industry. We sincerely believe that the decision-making authorities would have taken note of the anguish and agony of the Pensioners and the Retirees. Till complete resolution of all pending demands, CBPRO will remain in the path of agitation.
- 2. As per the declared programme of CBPRO, the members of the different constituents were to send mails containing different long pending issues of Bank Pensioners and Retirees to the Hon'ble Members of the Lok Sabha and Rajya Sabha of the constituency where he/she resides. When the organization was all set to issue the circular, the most unfortunate incident of the brutal killings of innocent people by the terrorists took place at Pahalgam. Responding to the very Philosophy of ours that the Nation is first, the Organization is second and the Individual is the last, CBPRO halted the programme and stood by the National Government solidly as a body of patriotic citizens. The said programme now stands on hold.
- 3. In order to sensitize the membership across the country and also to draw the attention of the IBA, the GOI and all other stakeholders, we declare the following programmes under the banner of CBPRO and do hope that a unified image of the Retirees will be presented before the entire country in support of the demands for immediate resolution of all the pending issues which include, inter alia, pension updation, computation of special allowance for calculation of pension & gratuity, health insurance at affordable cost (for Banks other than SBI) and for bearing the premium by all Banks, formal consultative status, problems of the Resignees and other issues.
- 4. All the Constituents of CBPRO by making a perfect co-ordination amongst themselves are advised to organise a day- long programme of Hunger Strike culminating in a general meeting on 31<sup>st</sup> July, 2025. If the said programme cannot be organized on the given date for any reason whatsoever (like rains, permission from

concerned authorities), the state committee can fix an alternative date under advices to us. As it is a rainy season, the weather forecasts may be taken note of before fixing the suitable date. The members suffering from serious ailments which do not permit them to go for hunger strike will please avoid the fast. They will attend the general meetings only. On conclusion of the programme, a report may please be sent to the central office of the Organisation.

- 5. Again, depending on the climatic conditions, a suitable date will be fixed for holding a centralised Hunger Strike followed by a general meeting at the national capital Delhi in the month of August/ September 2025. All Constituents will be informed well in advance so that they can make suitable journey preparations for intending members to the National Capital.
- **6.** All the Constituents are requested to circulate the programme in the organizational tiers down the level. The constituents on receipt of this circular will make a co-ordination among themselves and workout the programmes. The programme may start at 9 to 10 am and may continue up to such time as the general meeting concludes.
- 7. We call upon All Bank Pensioners and Retirees Organisations to join the CBPRO Programmes in this Decisive Battle against Injustice, Ignominy and Discrimination hurled at us by the Powers that be, ignoring the Invaluable Services we rendered during our active service in the Banks making the Banking Industry the Most Vibrant and Dependable Vehicle of Economic Development.
- **8.** Media Publicity through Press Meets, Press Releases and Interviews about the gravity of Bank Pensioners and Retirees issues should be organised to highlight the Anti--Bank Pensioners and Retirees stand of the concerned Authorities like IBA, Bank Managements and Government. We also request Units to keep reporting to us about the preparation for the successful conduct of the Action Programmes announced by CBPRO.

Dear Comrades, Let us March on holding our Head held High for a Big Fight to wrest our rights.
