IBA MEDICAL INSURANCE SCHEME

Bank has extended time for joining the insurance scheme up to 31.3.2016. Requests for Withdrawal and refund of premium will be permitted up to 20.2.2016. This information we have already communicated to our members through SMS. Efforts for reimbursement of domiciliary treatment expenses are continuing. IBA has assured AIBOC in this regard. Procedure for obtaining E-card (Health Card) and method of availing cashless facility has been given in bank circulars and SBPRA circulars. For the new entrants into the scheme the data is not yet updated. HO: SWD is making efforts to rectify data inaccuracies. It may take a little more time. Meanwhile we have received reports from some of our members that they have already successfully availed cashless facility for major treatments. Let us hope that the dust settles soon and the scheme works smoothly benefitting the retirees.

GENERAL SECRETARY'S VISIT CO AND HO

On 3rd Feb 2016 SBPRA team visited Corporate Office, Bangalore. The team consisted of the undersigned and Com. S B Sai Prakash, Vice President, Com. After meeting executives in PD and other departments, the undersigned met CM and staff at SWD. Problems faced by our members in dealing with medical insurance scheme were highlighted. It was informed that due to various data entry mistakes at various stages the Updation of records is not completed and that all the problems will be solved sooner. The staff was highly cooperative and offered their unstinted services to the retirees. We thank Com. D M Devaiah for his cooperation during our HO visit.

FLOOD RELIEF LOANS TO PENSIONERS

We had requested the bank to help the retirees affected in the recent devastating floods in Chennai and adjoining areas by sanctioning loans at concessional rate. We are happy to inform that our request has been considered favourably. A communication has been sent by HO: SWD to Chennai FGMO on 2.2.2016 conveying the decision and the terms and conditions. Loans will be sanctioned by Branch Heads at Pension drawing branches based on self declaration - at Base Rate; Quantum limited to 3 months pension; with 60% cut back; repayable in 36 EMIs; on the guarantee of family member eligible for family pension and in case of loan to family pensioner a third party with sufficient income. The details of the scheme have already been communicated by us to our Chennai team with a request to extend all assistance to the needy in this regard. We thank the management of the bank for their kind gesture in the hour of need.
